CONSTRUCTION OF DISCUSSION FOR POSTPONEMENT OF 2024 ELECTIONS IN TVONE'S "DUA SISI" PROGRAM (ENTMAN FRAMING ANALYSIS)

ABSTRACT

The purpose of this research was to analyze the news framing scheme for the issue of postponing the 2024 Election, and to reveal news framing scheme for the issue of postponing the 2024 Election on TVOne's "Dua Sisi" program, the More Gaduh episode of President's Term Extension. This study used a qualitative approach with the method of media framing analysis, namely the Robert N Etman framing analysis model. The data collection technique was carried out by analyzing documents related to the discourse on the postponement of the 2024 Election and dividing it into four elements, namely defining problem, (diagnosing causes) estimating the source of the problem, (make moral judgment) moral decision, and (treatment recommendation) emphasizing resolution. The results of this research indicated that TVOne's "Dua Sisi" program tends to defend the president. Defining the problem regarding the postponement of the 2024 election is against the constitution, the estimated source of the problem of postponing the election heated up after being raised by three political parties supporting Jokowi, moral decisions should be subject to and obey the constitution, emphasizing the solution, namely that everyone has the right to voice their opinion as a democratic country. The construction of news about the postponement of the 2024 election can be seen from the topics of discussion, the arrangement of questions or narratives, the selection of sources and the display of visual images showing a tendency to construct news.

1. INTRODUCTION

Public understanding of media depends on the framing of reality by the media, so the public tends to be trapped from the results of media framing. In line with the social construction of reality, for Berger and Suci (1991), reality does not just appear or occur naturally, but is formed and constructed. Thus, emphasizing that reality is not single but multiple (plural).

The media interprets the issue before the issue is produced as a text. The media's interpretation of the issue has consequences for the public's interpretation of the issue in question. The media offers the public how to interpret issues, for instance, the TVOne mass media offers the public how viewers interpret the issue of postponing the 2024 General Election through the program "Dua Sisi" which is currently being widely discussed among the public.

Furthermore, election is media that declare people's sovereignty and it is a moment for the people to participate in the life of the state (Allcott & Gentzkow, 2017). The implementation of people's sovereignty lies in the direct elections, such as the election of state, regional or legislative council leaders.

The principle of popular sovereignty means giving space to the community as power holders to participate in the war in making decisions, without any influence from the authorities which

benefits one party and harms the other party.

With voter participation in determining leadership, election is a mechanism for selecting and delegating people's sovereignty to trusted people or political parties. However, ahead of the 2024 presidential election, the issue of postponing the 2024 elections has spread. President Joko Widodo, namely Abdul Muhaimin Iskandar or cak Imin. Following the PKB leadership, PAN chairman Zulkifli Hasan to Golkar Party chairman Airlangga Hartarto threw the same narrative to the public. Delaying the implementation of the 2024 elections is certainly contrary to the 1945 Constitution, Professor Yusril Ihsan Mahendra said.

Bila penundaan pemilu dilakukan, maka harus didahului dengan amandemen UUD 1945 atau dekrit presiden. Tentunya ini tidak mudah. Namun, saat ini tidak ada situasi krisis yang menjadi landasan kuat untuk dilakukan amandemen UUD 1945 atau dekrit presiden. Bila dipaksakan, justru berpotensi terjadinya kerusuhan politik. Muaranya justru memperburuk kondisi ekonomi bangsa dan upaya penanganan pandemi Covid-19....

If the postponement of the election is carried out, it must be preceded by an amendment to the 1945 Constitution or a presidential decree. Of course, this is not easy. However, currently there is no crisis situation which is a strong basis for amendments to the 1945 Constitution or a presidential decree. If forced, it has the potential for political unrest. The bottom line actually worsened the nation's economic conditions and efforts to deal with the Covid-19 pandemic....

A number of media raised the issue of postponing the 2024 election so that it became material for discourse in society which was published by a number of media, making this discourse extensive. This has become a controversy, seeing that the debate over the postponement of the 2024 elections was facilitated by the media. Moreover in the context of the media's position, the media not only facilitates channeling the views of the masses that on the other hand is pro regarding the discourse on postponing the 2024 elections and one side it against this discourse, but the media has its own attitude regarding the discourse on postponing the 2024 elections where the public's point of view tends to follow the media view.

The existence of the media as news coverage, especially TVOne, it is considered to have the potential to give meaning to reality related to the issue of discourse on the postponement of the 2024 Election. It is as a pioneer in news coverage with the portion of the program and being more information than entertainment, and it tends to be used as a reference issue. Based on the description above, this is a debate and interesting to study because this issue is still hotly discussed in various circles. Considering that it is not long before the 2024 elections will be held, this issue is reaping pros and cons in society.

This tendency made researchers interested in conducting further research to analyze the reality framing scheme related to the issue of postponing the 2024 Election through TVOne's "Dua Sisi" program in the episode "Lebih Gaduh untuk Perpanjangan Masa Jabatan Presiden" (More Noisy for President's Term Extension) which aired on March 4, 2022.

The reason for raising the issue of postponing the 2024 elections is because in Indonesia there has never been an issue of postponing elections so far, in this case extending the presidential term to 3 terms due to the desire of certain groups to maintain President Jokowi's 3 terms.

The researcher chose TVOne's "Dua Sisi" program because it always presents sources from

the pros and cons and it is a pioneer in reporting with the portion of the program being more information than entertainment.

This research is expected to provide a reference for students in conducting research using Robert N Etman's framing analysis technique (1996) as well as provide benefits for readers or the public about how to analyze every news report in the media or to find out how the media composes a news story, as well as to increase knowledge in the world.

2. LITERATURE REVIEW

A. Media Construction in Content and Text Production

The concept of the social construction of mass media was introduced by interpretative sociologist Berger and Luckman (1967) through the book The Construction of Reality: A Treatise in the Sociological of Knowledge. This theory explains social processes through the actions and interactions, where individuals intensely create a reality, and that is subjectively experienced together. In this view, according to Berger (2017), humans and society are dialectical, dynamic and plural products.

According to Berger (2017), reality is not scientifically established, nor it is something that was sent down by God, but instead, it is formed and constructed in such a way. Everyone can have a different construction of a reality such as experience, preferences, certain education, and a certain social or social environment will interpret the social reality with their respective constructions.

There are two terms in Berger's sociological knowledge, namely reality and knowledge. Berger and Luckman (1967) explained that social reality separates the understanding of reality and knowledge. Reality is interpreted as a quality contained in realities that are recognized as being that does not depend on our own will (Rovelli, 2018; Rahman & Weda, 2019). Whereas knowledge is interpreted as certainty that realities are real and have specific characteristics (Rahman, 2018; Andini et al., 2022). Furthermore, there are two reality objects included in knowledge, namely subjective reality and objective reality.

B. Robert N Entman Framing Model Analysis (1993)

Framing is a technique of framing an event to find out what point of view the media uses when compiling, packaging and presenting news (Ali & Hasan, 2022). Framing analysis can simply be described as an analysis to find out how the reality of events, actors, groups, or whatever is framed by the media (D'Angelo, 2009).

Framing analysis is an approach to see how reality is formed and constructed by the media (Fahmy, 2010). The process of forming and constructing that reality, and the end result is certain parts of reality that are more prominent and easier to recognize. The protrusion is to increase the probability that the recipient will receive information, so that it can be seen the message more sharply and it can be stored in the memory of the recipient of the message (Cuesta-Claros et al., 2022).

Robert N Entman in Eriyanto (2002) revealed that in order to see the framing process, there are two major dimensions that must be considered, namely the selection of issues and the emphasis or prominence of certain aspects of reality/ issues.

C. Talk show as Media Reporting

Generally, talk show is a popular term that comes from a foreign language (Mittell, 2003). Talk means conversation/ conversation/ talk, while show means show/ exhibition/ spectacle. From these two words, when it combined, it means the conversation that is being shown furthermore, the talk show requires program material to be designed in such a way, for instance the theme to be conveyed, when, how to deliver it, so that principles or rules are needed. Talk shows usually present guests based on the topics raised as talks in the talk show (Rahman & Rahman, 2021; Hamuddin et al., 2022).

D. Media Construction based on the Islamic View

In this information age, the mass media has a very large influence on public opinion. In fact, the function of the media often does not run in balance. The function of entertaining is often more prominent because of the encouragement of various interests, including business interests, so that the function of education is sometimes pushed or defeated (Huang et al., 2021; Rahman et al., 2019). From the description above, there are two mass media technologies referred to in broadcasting, namely radio and television. Television as a medium for sending and disseminating information in the form of technology needs to be a reference for broadcasting ethics, one of which comes from religious teachings (Adornato, 2014). The principles of broadcasting ethics

based on Islamic views is: OS. An-Nahal/16:125.

According to M. Quraish Shihab, this verse described three kinds of da'wah methods that must have high intellectuals ordered to convey it with wisdom, namely dialogue with wise words based on the level of intelligence. Lay people are ordered to apply mau'izah, namely giving advice and parables that touch the soul according to their simple level of knowledge. Meanwhile, the experts on the Bible and adherents of other religions are ordered to use debate in a good way, namely with subtle logic and rhetoric, free from violence and swearing. Information broadcasting, both religious information and formal information should be done in a wise manner with hikmah, in this context is paying attention to time, place, and conditions of society. Broadcast content should contain good educational values, encourage people to progress, has noble character, as implied in the verse above. Conveying information is also done through exchange of ideas (discussion) in a good way, for example through talk shows.

3. METHOD

A. Types of Research

This research used a qualitative approach. Meanwhile, qualitative descriptive research is more appropriate for examining issues that require in-depth study, such as the problem of the effect of the media on viewers' views on one media show, or the problem of implementing public policies in society and so on (Nassaji, 2020).

This research used Robert N Entman's framing analysis model to analyze framing in the news about the postponement of the 2024 Election on TVOne's "Dua Sisi" program episode "Lagi Gaduh Perpanjngan Masa Jabatan Presiden" (There's More Noisy on the Extension of the President's Term of Office) which airs on March 4, 2022.

B. Research Approach

The research used a scientific approach to communication science with the Robert N Entman framing analysis model. Framing is an approach to find out how the perspective or point of view is used by journalists when selecting issues that highlight certain aspects of reality by the media.

Robert N Entman's framing model is divided into four elements, the four-element model defines the problem, diagnoses causes (estimates the problem or source of the problem), makes moral judgment (makes a moral decision), and treats recommendation (emphasizes resolution)

4. RESULT

A. General Description of the Research Object

1) TVOne Profile

TVOne is a national television station in Indonesia. It was previously named LATIVI from the use of the name PT. Lativi Rekatama Media. This television station was established on July 30, 2002 by Abdul Latief and belongs to Latief Corporation. The concept of organizing the program initially featured a lot of issues related to the occult, eroticism, smelling of crime and several other entertainment programs.

Progressively TVOne has succeeded in inspiring Indonesian people aged 15 years and over to think forward and make improvements for themselves and the surrounding community through news and sports programs both nationally and internationally. For programs in the categories of news, current, affairs and sports, TVOne is able to prove its seriousness in implementing this strategy in an innovative format both in terms of news and program presentation.

2) News Framing of Postponement of the 2024 Election on TVOne's "Dua Sisi" Program

This research used the framing analysis method to find out how the perspective or point of view is used by journalists when selecting issues or events or highlighting certain aspects of reality by the media. Framing is used by the media by selecting certain issues and ignoring other issues, as well as highlighting aspects of certain issues and using various discourse strategies and prominent placements, the media also used graphics to support and strengthen prominence, the use of certain labels when describing the person or event being reported. The word salience is defined as making information more noticed, meaningful, and memorable.

Robert N Etman's framing analysis model in news about the postponement of the 2024 Election on TVOne's "Dua Sisi" program episode "Lagi Gaduh Perpanjangan Masa Jabata Presiden" (There's More Noisy about Extending the President's Term of Office).

The news transcripts from TVOne's "Dua Sisi" that have been obtained regarding the discourse on postponing the 2024 Election is then analyzed using the Etman framing model which divides the framing tools into four elements including define problems, diagnose causes, make moral judgments, and treatment recommendations, along with the analysis:

a) Define Problem

Dua Sisi TVOne on the March 4 2022 edition raised a piece of news which was packaged in the form of a talk show with the episode title "Lagi Gaduh Permanjangan Masa Jabatan Presiden" (Again Noisy for Prolonging the President's Term of Office), the news in the broadcast raised issues related to the discourse on postponing the 2024 Election. The discourse on postponing the 2024 Election is a form of violation of the constitution.

"Siapapun aktor yang mencetuskan ide penambahan atau pemunduran pemilu ini itu jahat bener buat Indonesia dia itu jahat sekali bukan hanya menghianati demokrasi tapi dia mencoba mengkudeta KPU, KPU itukan sudah menetapkan 14 Februari 2024".

"Whoever the actor who came up with the idea of adding or withdrawing this election is really evil for Indonesia, he is very evil, not only betraying democracy but he is trying to coup the KPU, the KPU has already set February 14, 2024".

The description above stated by Hendri Satrio who is a political observer. In the quotation above, the researcher considers that the idea or proposal to postpone or extend the term of office is very problematic. This is because it is contrary to the 1945 constitution which explains in article 7 of the 1945 Constitution of the Republic of Indonesia that the president and vice president hold office for five years, and it can be re-elected with the same position for only one term of office, in which case the president and vice president are allowed maximum of two periods. If you look at this article, President Jokowi cannot continue his term of office after occupying two terms as president. The KPU has also set a schedule for the elections to be held on February 14, 2024. Postponing the 2024 elections indirectly makes the implementation no longer periodic and every five years. Meanwhile, in Indonesia, we are a country that holds democratic elections.

The definition of the problem in the news above regarding the discourse on postponing the 2024 Election, it is a dispute for and against the issue of postponing the 2024 Election due to the wishes of certain groups who wish to maintain or extend the presidential term. Although it is clear that the issue of delaying the election is against the constitution. However, this issue continues to be rolled out to the public to the point of controversy, both among the political elite and among the people who are none other than potential voters later.

b) Diagnose Causes (Estimating the problem or source of the problem)

The cause of the problem from TVOne's "Dua Sisi" news on March 4th 2022 edition, it was reported that the discourse on postponing the 2024 Election heated up after being raised by a number of political elites for various reasons, one of which was the economic condition which was in a period of improvement after the Covid-19 pandemic was the main reason for the proposed postponement Election 2024. Discourse on postponing the 2024 election continues to roll, after PKB Chairman Muhaimin Iskandar suddenly proposed it to the public. Furthemore, it was followed again by the Chair of PAN and Golkar who also agreed to the proposed

postponement of the election. Not only that, previously Minister Bhalil had launched a narrative regarding the postponement of the elections based on the results of his discussions with several businessmen. The following is a statement made by one of the political elites who is a political party that supports Jokowi.

"Saya mengusulkan pemilu Tahun 2024 ditunda satu atau dua tahun agar momentum perbaikan ekonomi ini tidak hilang dan kemudian tidak terjadi fress untuk mengganti staknasi selama dua tahun bersama jokowi"

"I propose that the 2024 election be postponed for one or two years so that the momentum for economic improvement is not lost and then there is no fress to replace the two-year stagnation with Jokowi"

From the statement by PKB Chairman Muhaimin Iskandar above, the researcher thinks that this statement should not have happened because a good politician must understand very well about the applicable constitution, where in Indonesia is a country that holds democratic elections. The existence of this statement indirectly undermines the democratic system and it seems to undermine the ability and intelligence of other Indonesian leaders who are ready to continue Jokowi's government. President Joko Widodo has repeatedly stated his attitude regarding this discourse and admitted that he does not intend to serve for up to three terms. Muhaimin Iskandar himself proposed postponing the 2024 elections on the basis of the momentum of economic improvement from the Covid-19 pandemic. In fact, Indonesia itself is one of the countries that has succeeded in controlling Covid-19 with a very high vaccination rate, and the economy grew by up to 3%.

The researcher's description regarding the causes of the problem from the discourse on postponing the 2024 Election, there are statements by a number of political elites regarding the proposal or postponement of the 2024 Election with the fundamental reason being a moment of economic recovery. Statements from a number of political elites were very influential in driving public opinion, especially regarding the discourse on postponing the 2024 elections and succeeded in creating controversy among the public or among the political elites themselves.

c) Make Moral Judgement

The moral assessment or decision made by TVOne's "Dua Sisi" in the March 4 2022 edition of the news was when a number of political parties proposed postponing the 2024 elections for various reasons. However, with a number of reasons put forward by the political elite, it actually created controversy and commotion in the midst of the political elite and became a hot topic of conversation among the people. So that this issue becomes a debate without any clarity as to who the actual actor is that gave rise to this discourse. Jokowi said he disagrees with the discourse on postponing the 2024 elections.

"Bahwa tidak ada alasan dan alandasan konstitusi yang membenarkan apakah presiden tiga periode maupun perpanjangan masa jabatan itu yang pertama dan yang kedua tidak terpenuhi syarat etik maupun objektif untuk mengadakan itu jadi oleh karena itu".

"That there are no constitutional reasons and grounds that justify whether the three-term president or the extension of the term of office, the first and the second, did not fulfill the ethical and objective requirements to hold it, so that's why."

Dedy Sitorus explained that there is no reason that can be used for the discourse on postponing the 2024 elections, whether for economic reasons, people's aspirations, results of discussions with businessmen, or survey results.

The moral decision that can be taken is the discourse or issue of postponing the 2024 elections raised by a number of political elites are good politicians who actually understand the constitution that applies in Indonesia, especially regarding elections. Talking about the constitution is not only talking about the text, but also talking about constitutional values which are actually very strong regarding the limitation of power. A number of politicians who have proposed the discourse of postponing the 2024 elections should feel ashamed because they are talking about something that is unconstitutional. Although the main reason on behalf of the people is to accommodate the aspirations of several entrepreneurs as a momentum for economic improvement, as well as a momentum for economic improvement after the Covid-19 pandemic.

On behalf of the people in conveying aspirations to the public is an easy thing, including the politicians who proposed the discourse on postponing the 2024 elections. In the concept of politics, it does not only talk about the text of the constitution which may be changed, but also talk about the ideas contained in the constitution about limiting powers. If the political elite is not wise in responding to this matter, it can undermine the democratic system, because the condition for democracy is the existence of regular elections.

d) Treatment Recommendation

The position of the MPR (People's Consultative Assembly) is clear that the schedule for the 2024 elections is set for February 14, 2024. To resolve the issue of postponing the 2024 general election, as a democratic country everyone has the right to voice their opinion, the existence of discourse or the issue of postponing the election is a natural thing as a democracy and it should respect each other. Living in a democratic country, differences of opinion are a natural thing, and political maneuvers carried out by a number of political elites are no exception, both pro and con regarding the proposed postponement of the election. The 2024 election schedule has been set, if it compares the scale between those who support the election and those who do not support the election, it is clear that the number of seats for political parties supporting the 2024 election in the DPR totals 187 seats and political parties that do not support the 2024 elections in the DPR (House of Representatives) totaling 388 seats, meaning that they have it is impossible for discourse or issues of postponing the 2024 Election to occur. This means that there is almost no chance of postponing the election because it is against the constitution.

The constructionist approach has its own meaning about how the media or journalists present the news. In the process of conveying information, the media sees it from a perspective with subjective considerations. On the other hand, media alignments generally cannot avoid the possibility of subjectivity when selecting facts or reality. In this case the media tends to be subjective on the selected facts or reality.

The description of the mass media shows that the construction of news about the postponement of the 2024 Election on TVOne's "Dua Sisi" program tends to be subjective. The construction of the news delivered by the TVOne mass media on the "Dua Sisi" program regarding the discourse on postponing the 2024 Election tends to defend President Jokowi. It can be seen what viewpoints are used by the media or journalists when raising issues and making them into a news that is packaged in a talk show concept.

The point of view in presenting news about the postponement of the 2024 Election, it shows the views of sources or guest stars from the point of view of the emergence of the proposal to postpone the 2024 Election which was triggered by a number of political elites for the approval of the proposed postponement of the election with their own reasons respectively, without further clarifying with the political elite involved in the proposed postponement or extension of the president's term of office.

The construction of the TVOne mass media through the "Dua Sisi" program, the researchers found that news on the postponement of elections is important and has a very large influence, is controversial which attracts the attention of the public and the influence of postponing elections has an impact on society which raises pros and cons to the discourse on postponing elections. Because of this, TVOne, especially the "Dua Sisi" program, chose him as the subject of the news and used the title "Challenging Again for Extension of the President's Term of Office on March 4, 2022.

As television, which has a different tagline, you can see how TVOne constructs the news that happened at that time.

"Kalau isunya dinamis yakinlan isu ini sudah dibicarakan kalau melihat dengan data yang dikluarkan survai hari ini menurut sepemahaman kami memang isu ini masih banyak berputar ditataran elit politik sementara prioritas presiden adalah isu-isu yang berhubungan dengan gresrut jadi ketika hal ini tidak ketemu makanya isu ini bukan menjadi prioritas utama artinya bukan hal yang difokuskan"

"If the issue is dynamic, I'm sure this issue has been discussed. If you look at the data released today's survey, according to our understanding, this issue still revolves a lot at the level of the political elite, while the president's priority is issues related to Gresrut, so when this is not met, this issue not a top priority means not the thing to focus on"

Faldo Maldini's statement above emphasized that the president's focus is not on the discourse on postponing the election which is being rolled out by a number of media. This is considered because it is irrelevant to what is the progress of the president. However, he as the special staff secretary of state gave information that what the president focused on was IKN, major transformations, digitization, recruiting national talents and increasing the prices of some basic foodstuffs. The issue of proposing a postponement of the election was rolled out by a number of political elites, who are one of the political elements in Indonesia, therefore the discourse on proposed postponement or extension of the presidential term is still heard by the president as the head of state and accommodates the aspirations of those who agree and disagree.

"Alasannya ketebak aja paling bukan saya atau nggak ikut-ikut. tapi kalau pak Jokowi mengnggap isu ini serius dia akan tampil untuk mengatakan bahwa tolong PKB, PAN, dan Golkar anda ini ndak usah lucu-luculah diam saja bantu pemerintah menyelesaikan tujuan pembangunan itukan keren tapi sampai ini isu ini dibuat terbuka dibuat kemana mana bahkan tuduhan- tuduhan itu makin lama makin menyerang pak jokowi".

"The reason you can guess is at least not me or not participating. but if

Pak Jokowi takes this issue seriously he will appear to say that please PKB, PAN, and Golkar, you don't need to be funny, just keep quiet and help the government complete development goals, that's cool, but so far this issue has been made open, made everywhere, even accusations - The accusations increasingly attacked Pak Jokowi.

In the quote above expressed by Hendri Satrio, trying to defend the president for the discourse that was rolled out to him. It can be seen when he tried to explain that when this issue is serious which in the sense of becoming a political movement the president will definitely appear. This was addressed to PKB, PAN and Golkar which are none other than political parties supporting the president. This issue should be stopped immediately by the one who is expressly accused, none other than President Jokowi. So, this discourse does not become controversial without clarity on the status of whether the discourse or proposal for the 2024 election will be carried out or not.

The quote is constructed to mean that anyone who becomes an actor in this discourse is a bad person because it try to go against the constitution and turn the proposed discourse on delaying or extending the presidential term as a political show, which not only undermines the democratic system in Indonesia but also tries to coup the KPU. Meanwhile, the KPU itself has set February 14th 2023 as the election schedule later. The proposal to postpone or extend the presidential term is a representation that President Jokowi will remain president because only the Jokowi government can complete economic recovery and economic development after Covid-19 for about two years.

"Permit or not, the answer is always possible, the problem is whether we need it or not, because if we only talk about whether or not Article 37 of our Constitution is actually very easy to change our constitution, because it is said that one third submitting an agenda can advance on the table, then two-thirds of the meeting can start the meeting and half plus one approve we can do it and our need to talk about strategy doesn't mean I ordered it but I think we really have to reject the need to amend article 22 E of the constitution which says that every five years we have to hold elections and if we try to only extend the presidency it means article 7 of the Constitution".

The quotes by Bivitri Susanti as a research constitutional law expert considers the above quote to be constructed that the proposal to postpone elections or extend the term of office of

the president can be carried out but must go through an amendment. Amendments themselves are official changes to certain official documents or notes, especially to bring things that are considered better.

The changes referred to in the amendments are either in the form of additions or deletions of records that are incorrect or deemed no longer appropriate, such as proposed postponements or extensions of the president's term of office. In this case the amendments were made to clarify the laws contained therein as the constitution confirms that every five years an election must be held which is then amended and allows proposals or extensions of the presidential term to be made.

To strengthen the news construction, the discourse or postponement of the 2024 election is strengthened by showing a comparison of supporting political parties and political parties that reject the discourse on postponing the 2024 election or extending the presidential term by displaying a calculation of the number of seats in the DPR from a number of political parties proposing discourse on postponing the 2024 election and a number of political parties that reject the discourse on delaying the 2024 elections are the PKB party 58 seats, the PAN party 44 seats, the GOLKAR party 85 seats, a total of 187 seats. Furthermore, the number of political party seats that rejected the discourse on postponing the 2024 Election in the DPR, there are six political parties including PDI-P with a total of 128 seats, Gerinra with 78 seats, Nasdem party 59 seats, Democrats party 54 seats, PKS party 50 seats, and PPP party 19 seats, with a total of there are 388 seats in the DPR. It shows that one of the main reasons for the discourse on postponing the 2024 elections is due to economic reasons, which is currently undergoing a period of improvement after the Covid-19 pandemic which lasted for about two years.

The next headline provides information that the discourse on postponing the 2024 elections is rolling again due to several political elites participating in proposing and agreeing to the discourse on postponing the 2024 elections. The political parties in question include the general chairman of PKB Muhaimin Iskandar, followed by PAN and Golkar who also agreed to the proposal.

The results of researchers' observations on TVOne related to the discourse on postponing the 2024 Election in the "Dua Sisi" program which was packaged in the form of a talk show on the March 4th 2022 edition. The discussion that took place on this program presented a number of sources as supporters of construction such as Hendri Satrio (political observer), Bivitri Susanti (statutory law expert), Faldo Maldini (special staff secretary of state), Deddy Sitorus (PDI-P politician). To provide confirmation and response regarding the discourse on postponing elections or extending the term of office of the president. In this research, news excerpts on the use of language in the concept of talk shows and visual images have been discussed in this program. Then the resource person was given a number of questions related to the discourse on postponing the 2024 Election by event host Dwi Anggia. It appears that a number of sources gave different responses with the strengthening of the arguments of each source.

From the previous explanation in the earlier, it can be seen that TVOne's news frame regarding the discourse on postponing the 2024 elections tends to defend the president and it considers that suggestions for postponing elections or extending the term of office of the president are commonplace as a democratic country, and it reinforces that there is almost no chance to realize the discourse on postponement of elections 2024 which can be identified from news narratives, visual images, and a number of sources' arguments. From the construction of TVOne's "Dua Sisi" program regarding the discourse on the postponement of the 2024

Election, it can be seen that the topics of discussion, the arrangement of questions or narratives, the selection of sources, and the display of visual images, in general have shown a general tendency for this program to construct news about the postponement of the election.

The construction of the news discourse on the postponement of the 2024 Election can be seen from the selection of the facts presented. One of the ideas contained in the construction of TVOne's "Dua Sisi" program is that the schedule for the 2024 elections has been determined by the KPU (General Elections Commission) which emphasizes that it is impossible for the discourse to postpone the 2024 elections to be carried out and it shows that there is no constitution which justifies that postponing the elections can be carried out by strengthening the Article 22 E which says that every five years an election must be held.

Everyone has certain experiences and preferences in interpreting a reality, including the discourse on postponing the 2024 elections which will be interpreted by each person according to their own construction. Berger and Tomas put forward the theory regarding the social construction of mass media, the researcher understands that the discourse on postponing or extending the presidential term is something that was formed and constructed in such a way through TVOne's "Dua Sisi" program.

The TVOne mass media is constructing a discourse on postponing the 2024 Election which will be broadcast based on the interests that will be fought for or based on the interpretation of the TVOne media workers themselves. Starting from journalists, who search for and select facts related to the discourse on postponing the 2024 elections which will later be made into a report and of course based on the construction of journalists themselves in seeing the reality of the discourse on postponing the 2024 elections.

5. CONCLUSIONS

The news framing of the issue of postponing the 2024 election on TVOne's "Dua Sisi" program episode "More Gaduh for Extending the President's Term of Office" using the Rebert N Etman framing model analysis that defines the problem, namely the discourse on postponing the 2024 election against the constitution, diagnosing cause (estimating problem or source of the problem), namely the discourse on postponing the election heated up after being raised by three political parties supporting Jokowi regarding the approval of the postponement of the 2024 election, make moral judgment (make a moral decision), (emphasizing settlement), that is, everyone has the right to voice their opinion and we should respect each other for differences of opinion as a democracy.

The construction of TVOne's reporting regarding the issue of postponing the 2024 Election in the TVOne show "Dua Sisi" episode "Lebih Gaduh untuk Perpanjangan Masa Jabatan Presiden" (More Noisy for Extending the President's Term) is that from the news presentation above it can be seen that TVOne's news frame regarding the discourse on postponing the 2024 Election tends to defend the president and considers the proposed postponement elections or extending the term of office of the president is a natural thing as a democratic country, and it confirms that there is almost no chance to materialize the discourse on postponement of elections. The 2024 election can be identified from news narratives, visual images, and a number of sources' arguments. One of the ideas contained in the development of TVOne's "Dua Sisi" program is that the schedule for the 2024 election has been determined by the KPU, in this case emphasizing that it is impossible to discuss postponing the 2024 election and showing that there is no constitution which justifies that postponing the elections can be done by providing
